**Non-approved underwear, shoes, gloves and balaclavas: Undergarments sold by Power On Racewear which are NOT approved by the FIA**

Dear Sir/Madam,

During the quality control process of the products certified to the FIA 8856-2000 Standard, we found several product (Shoes, Gloves and Balaclava) labelled with a label similar to the FIA label stating that the products are IN COMPLIANCE WITH FIA STANDARD 8856-2000 (see Figures 1, 2 and 3).

You can see that the label used on these products is different from the label used on FIA approved products (size and layout). In addition, Power On Racewear is not listed in the FIA Technical List N°27 - part 2 “List of approved under garment manufacturers”, meaning that they are NOT approved by the FIA to produce undergarments according to the FIA 8856-2000 standard. We would like to highlight that you can find the updated FIA Technical List N°27 on the FIA website through the following link (<http://www.fia.com/sport/homologation>)

As these above products are NOT FIA approved, there is no guarantee that they can give the minimum level of protection which the FIA approved products can provide drivers with.

The use of these products is prohibited in all cases in which compliance with the FIA 8856-2000 standard is mandatory.
